## **RIGHT OF WAY EASEMENT FOR UTILITY SERVICES**

The Undersigned has applied to EMC for Electric Power services for said real estate, and to provide said service the Easement herein granted shall authorize EMC, its employees, agents and contractors to enter upon said Lands for inspection, engineering, construction, reconstruction, operation and maintenance of an electric distribution line or system on said property. The Easement granted by virtue hereof shall be twenty feet (40') in width, measured ten feet (20') to each side from the location of the proposed electric line. EMC shall have the right to control vegetation by trimming, cutting and the use of chemical herbicides (not disapproved by EPA), or any reasonable method of controls that may interfere or threaten to endanger the operation and maintenance of said line or system. EMC may license, permit, or otherwise agree to joint use or occupancy of the line or system by others for electrification or communication purposes.

All poles, lines, wires and other facilities installed by EMC shall remain the property of EMC removable at its option upon termination of service to or on said lands.

It is further agreed that said Easement shall authorize and permit EMC to extend electric service from the initial line constructed to serve the undersigned, to other locations within said tract, and also to locations not within the described tract, but adjacent to any boundary thereof. Such extensions, if made, shall be located by EMC to minimize inconvenience and impact upon the said tract and the Owners use thereof.
